It is no longer news that many well qualified women who have indicated interest to contest for certain elective posts have experienced brutal intimidation, and often rigged out in preference to unqualified male contestants. The so-called split model for the posting of directives, while being different from the approach proposed

by the Commission, strikes a good balance between the protection of the social rights of drivers and the freedom for operators to provide cross-border transport services.

We can support all amendments which maintain the balance between the freedom to provide transport services, improve working conditions and reduce administrative burdens.
